



## OFFICIAL CONTEST RULES & REGULATIONS

"Spring Cha-Ching \$5,000 giveaway"

The Peninsula Co-op Spring Cha-Ching Contest (the "**Contest**") is sponsored by Peninsula Co-op (the "**Sponsor**"). The Contest begins 12:00:00 a.m. (PST) on April 4, 2022 (the "**Contest Start Date**") and ends 11:59 pm (PST) on May 8, 2022 (the "**Contest Closing Date**"), known as the "**Contest Period**".

### 1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

Purchase Entry Method: To enter, an Eligible Entrant must go to any Peninsula Co-op (gas centre, food store or PenCo Liquor) location ("Participating Store") and enter to win by scanning the QR Code on the display posters located inside the store, on the door and/or by the pumps at the gas centres.

All entries must be received on or before the Contest Closing Date.

### 2. ELIGIBILITY:

#### Eligible

To enter the Contest and be eligible to win the prize in the Contest, a person must be a resident of Vancouver Island and be over the age of 19 years at the time of the Contest Start Date.

#### Not Eligible

Residents outside of Vancouver Island are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family\* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's member retail co-operatives ("**Co-ops**"), the Co-ops' Board of Directors as well as the immediate family\* and those domiciled with the Co-ops' employees and the Co-ops' Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Co-ops' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family\* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

\* "*Immediate family*" includes parents, siblings, children and spouses.

### 3. PRIZES:

**WEEK 1:** \$250 Peninsula Co-op gift card

**WEEK 2:** \$500 Peninsula Co-op gift card

**WEEK 3:** \$750 Peninsula Co-op gift card

**WEEK 4:** \$1,000 Peninsula Co-op gift card

**WEEK 5:** \$2,500 Peninsula Co-op gift card

Prizes must be accepted as awarded. Prizes may not be sold, converted to cash, are non-transferable, and no substitutions are permitted. One prize per winning entry; one prize per household. The Sponsor reserves the right, in the event that a prize or any component of a prize cannot be awarded as described for any reason, to substitute another prize of equal or greater value without liability.

The chances of being selected are dependent upon the total number of eligible entries received during the Contest Period.

#### **4. PRIZE WINNER:**

The Sponsor will randomly draw 5 valid entries during the promotion on the following dates:

- Week 1 prize - One (1) valid entry form will be drawn on April 11, 2022
- Week 2 prize - One (1) valid entry form will be drawn on April 18, 2022
- Week 3 prize - One (1) valid entry form will be drawn on April 25, 2022
- Week 4 prize - One (1) valid entry form will be drawn on May 2, 2022
- Week 5 prize - One (1) valid entry form will be drawn on May 9, 2022

The five (5) named individuals will be rewarded their prize by May 15, 2022. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor. Prize winners must answer a mathematical skill testing question correctly and sign a release in order to claim their corresponding prize.

#### **5. GENERAL:**

By entering the Contest, entrants agree to abide by these Official Rules and the decisions of the Sponsor with respect to all aspects of the Contest, which are final. This Contest is subject to all applicable federal, provincial and municipal laws. The Sponsor reserves the right to disqualify any entrant in the event of fraudulent Contest entry or other violation of these Official Rules. Entry forms are subject to verification and void if obtained illegitimately, or if altered, mutilated, forged, tampered with or irregular in any way.

Subject to applicable law, the Sponsor reserves the right, in its sole discretion and for any reason, to cancel, terminate, modify these Official Rules or administration of the Contest or suspend this Contest in whole or in part without prior notice and with no obligation or liability. In the Sponsor's sole discretion, a Prize Winner may be selected by randomly drawing from among all valid entries received up to the time of cancellation, termination or suspension.

By participating in the Contest, entrants agree to release and indemnify the Sponsor and any independent judging organization as well as their respective parents, affiliates, member retail co-operatives, agents and contractors, including advertising and promotional agencies, and their directors, officers and employees, from any and all losses, expenses (including legal fees), damages and claims of any kind in connection with the Contest or resulting from the acceptance, possession or use of any prize, including without limitation any loss, personal injury, death, property damage, or claims based on publicity rights, defamation or invasion of privacy.

Under no circumstances will the Sponsor, its member retail co-operatives, subsidiaries, affiliates, independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotional agencies, be responsible for any injuries, loss or damages of any kind (compensatory, direct, incidental, indirect, consequential or otherwise) with respect to or in any way arising from, this Contest or the prize awarded. In no event shall the Sponsor be required to award more prizes than what is indicated in these Official Rules or award the prizes otherwise than in accordance with these Official Rules.

**6. PRIVACY:**

The Sponsor, Peninsula Consumer Services Co-operative, respects your right to privacy. Personal information collected is not sold, rented or loaned to any third parties.

The Sponsor will use the information collected solely to administer the Contest. No correspondence will be entered into except with selected entrants.

Peninsula Consumer Services Co-operative will handle personal information in accordance with its privacy policies and practices, which can be accessed by contacting Peninsula Co-op Administrative Office and in accordance with applicable laws. By completing and submitting a Contest entry form you consent to the collection use and disclosure of your personal information for the purposes stated herein.
