We are working with Survey & Ballot Systems (SBS), a trusted and proven provider of online and mail-in voting services, to give members a choice in how they cast their vote.

Baker Tilly Victoria continues to support the Co-op's elections by managing member requests and safekeeping mailed-in ballots prior to tabulation by SBS.

Members who vote online will have the option to provide their email address to Peninsula Co-op as we move to a completely electronic platform in the near future, conveniently receiving voting packages for future elections via email only. It's a quick and easy option that's great for the environment too!

Peninsula Co-op originally started in 1977. RANDY BOGLE. Endorsed

The Committee undertakes an evaluation of the current Board, and identifies additional skills, business experience, or qualifications which would enhance the Board's effectiveness and diversity for the benefit of the membership. The Nominations Committee carefully reviews the nominations received and endorses individuals who offer significant expertise to Peninsula Co-op's Board. The Nominations Committee assesses all the information provided by each nominee. Nominees are only endorsed after an extensive process involving meeting with the Nominations Committee, analysis of past work experience and their community contributions.
