

# OFFICIAL CONTEST RULES & REGULATIONS

## “Peninsula Co-op 12 Days of Giveaways”

The Peninsula Co-op 12 Days of Giveaways (the “**Contest**”) is sponsored by Peninsula Cooperative Consumer Services (the “**Sponsor**”). The Contest begins 6:00:00 a.m. (PST) on December 1st, 2023 (the “**Contest Start Date**”) and ends 10:00 pm (PST) on December 12, 2023 (the “**Contest Closing Date**”), known as the “**Contest Period**”.

### 1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

There is 1 way to enter the Contest, as follows:

Online Entry Method: To enter, an Eligible Entrant must go to any Peninsula Co-op Gas Centre, Food Store, PenCo Liquor Store or Liquor Express (“Participating Store”) and enter to win by scanning the QR Code Entry Form inside the location.

### 2. ELIGIBILITY:

#### *Eligible:*

To enter the Contest and be eligible to win the prize in the Contest, a person must be a resident of Vancouver Island and be over the age of 19 years at the time of the Contest Start Date.

#### *Not Eligible:*

Residents outside of Vancouver Island are not eligible to enter the Contest. The Sponsor’s employees and the Sponsor’s Board of Director as well as the immediate family\* and those domiciled with the Sponsor’s employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest. Employees of the Sponsor’s and the Co-ops’ operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family\* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

\* “Immediate family” includes parents, siblings, children and spouses.

The chances of being selected are dependent upon the total number of eligible entries received during the Contest Period.

Prize Winners will be contacted via email and must respond within one week (7 days) of receiving the notification to claim their prize. Failure to respond within this time frame will result in forfeiture of the prize, and an alternate winner may be selected. Prize Winners consent to the use of their name, address (city and province) and photograph without compensation, in any future publicity carried out by the Sponsor.

Entry forms are subject to verification and void if obtained illegitimately, or if altered, mutilated, forged, tampered with or irregular in any way. Subject to applicable law, the Sponsor reserves the right, in its sole discretion and for any reason, to cancel, terminate, modify these Official Rules or administration of the Contest or suspend this Contest in whole or in part without prior notice and with no obligation or liability. Under no circumstances will the Sponsor, its member retail co-operatives, subsidiaries, affiliates, independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotional agencies, be responsible for any injuries, loss or damages of any kind (compensatory, direct, incidental, indirect, consequential or otherwise) with respect to or in any way arising from, this Contest or the prize awarded. In no event shall the Sponsor be required to award more prizes than what is indicated in these Official Rules or award the prizes otherwise than in accordance with these Official Rules.

## **6. PRIVACY:**

The Sponsor, Peninsula Co-op, respects your right to privacy. Personal information collected is not sold, rented or loaned to any third parties. The Sponsor will use the information collected solely to administer the Contest. No correspondence will be entered into except with selected entrants. Peninsula Co-op will handle personal information in accordance with its privacy policies and practices, which can be accessed on its website or by contacting Peninsula Co-op Administrative Office and in accordance with applicable laws. By completing and submitting a Contest entry form you consent to the collection use and disclosure of your personal information for the purposes stated herein.
