VOTE ONLINE

We're moving to online voting! Next year, Peninsula Co-op is moving to a completely electronic ballot. Members will continue to receive election packages by Canada Post; however, votes will be cast via an on-line ballot platform. It's quick and easy and great for the environment too! For any members unable to participate in electronic voting, a paper ballot can be requested. For members who have opted-in to receive all election information via email, it will be the same easy process as this year: receive the election notice via email and cast your ballot online.

This year's election period opens on Tuesday, May 21st and closes at end of day Friday, June 7th. Digital ballots can be cast until midnight, June 7th. Paper ballots must be post-marked June 7th, and must be delivered by Canada Post to Baker Tilly offices by Wednesday, June 12th.
